Please read the following carefully to understand our views and practices regarding your personal data and how we will treat it. Information We May Collect From You

We may collect and process the following data about you:

Information you give us.

You may give us information about you by submitting an order with us through our site www.qmuli.com ("our site") or by corresponding with us by phone, e-mail or otherwise. This includes information you provide about yourself and/or your company when you register to use our site, if you report a problem with our site, when you choose to engage our services and when you make a payment to us. The information you give us may include:

- your full name/company name (if applicable);
- VAT number (if you are not from the UK);
- email address;
- phone number; and
- financial and credit card information.

Should you choose to engage our services, the following are examples of the specific types of information we may require from you:

- name/type of publication;
- size of advertisement;
- insertion date;

- advertiser;

- any special instructions you wish to be passed on to a publisher.

Information we collect about you.

With regard to each of your visits to our site we may automatically collect the following information:

Information we receive from other sources.

This data may be shared internally and combined with data collected on this site. We are also working closely with third parties and may receive information about you from them. Other third parties may include but are not limited to business partners, sub-contractors in technical, payment and delivery services, advertising networks, analytics providers, search information providers and credit reference agencies.

Information you give to us.

- to notify you about changes to our service; and
- to ensure that content from our site is presented in the most effective manner for you and for your computer.

Information we collect about you.

We will use this information:

- to administer our site and for internal operations, including troubleshooting, data analysis, testing, research, statistical and survey purposes;
- to improve our site to ensure that content is presented in the most effective manner for you and for your computer;
- to allow you to participate in interactive features of our service, when you choose to do so;
- as part of our efforts to keep our site safe and secure;
- to make suggestions and recommendations to you and other users of our site about goods or services that may interest you or them.

Information we receive from other sources.

We may combine this information with information you give to us and information we collect about you. We may us this information and the combined information for the purposes set out above (depending on the types of information we receive).

Disclosure of Your Information

We may share your information with selected third parties including:

- Business partners, suppliers and sub-contractors for the performance of any contract we enter into with them or you.
- Analytics and search engine providers that assist us in the improvement and optimisation of our site.
- Credit reference agencies for the purpose of assessing your credit score where this is a condition of us entering into a contract with you.

We may disclose your personal information to third parties:

- In the event that we sell or buy any business or assets, in which case we may disclose your personal data to the prospective seller or buyer of such business or assets.
- If Qmuli Limited or substantially all of its assets are acquired by a third party, in which case personal data held by it about its customers will be one of the transferred assets.

Where We Store Your Personal Data

All information you provide to us is stored on our secure servers. Any payment transactions will be encrypted via Paypal using SSL technology. We ask you not to share a password with anyone.
